Notice Concerning Change of Property Management Company

TOKYO, August 27, 2014 – SIA REIT, Inc. (hereafter referred to as "SIA REIT") announced that Simplex REIT Partners Inc., the asset management company to which SIA REIT entrusts management of its assets, today decided to conduct change (hereafter referred to as "the Change") of the property management company (hereafter referred to as the "PM Company"), as described below.

1. Overview of the Change

Concerning the Niigata Higashibori-dori Parking Building, which is owned by SIA REIT (hereafter referred to as the "Property"), the PM Company will be changed as of September 10, 2014 as follows.

2. Reason for the Change

SIA REIT reviewed the property management operations as the Property will be the sole property in Niigata-city owned by SIA REIT after the transfer of NEXT21^(Note). As a result of studying several candidates including the present PM Company, SIA REIT has decided to appoint The Dai-Ichi Building Co., Ltd. as the new PM Company with comprehensive consideration to their operation/management track record, emergency response capability, rationale behind fee levels, etc.
